You must complete the Global Entry enrollment process within 545 days (extended from 365) from the date that CBP conditionally approves your Global Entry application or ...

### **Scheduling Your Global Entry Interview Appointment ASAP ...**

When landing in an international terminal follow the signage directing you to CBP officers who can complete your Global Entry interview during your admissibility inspection. To complete the interview via EoA, you must be in possession of the following documents: A valid passport.

### **Enrollment on Arrival | U.S. Customs and Border Protection**

To apply for Global Entry, you must complete the online application. Once we review your application, you will be contacted to schedule an interview at one of the Global Entry Enrollment Centers. At the interview a CBP officer will: ask you questions, take your photo, and; collect biometric information, for example, scan your fingerprints.

### **Global Entry Enrollment Centers | U.S. Customs and Border ...**

The following original documents are usually required: A valid passport. If you travel using more than one passport, please bring them to the interview so that the information can be added to your file. This provides you with the ability to use either passport at the Global Entry kiosk; A permanent resident card (if applicable);

### **Trusted Traveler Program - What do I need to bring to my ...**

Applicants who are conditionally approved are typically allowed up to one year to complete their interview for Global Entry enrollment, although the CBP recently extended the window to 485 days.

### **COVID-19's Impact on Passports, Global Entry, TSA PreCheck**

The estimated average time to complete this application is 40 minutes for NEXUS, SENTRI, FAST and Global Entry, and 10 minutes for U.S. APEC Business Traveler Card (ABTC).
